# **NCWSC RENEWS OPERATING LICENCE**

The Company has successfully been licensed by the Water Services Regulatory Board (WASREB) for the next two years to offer water and sewerage services to the residents of Nairobi City County.

The approval for the operating license follows a public participation forum convened by WASREB, the water sector regulator, held at Kenyatta International Convention Centre (KICC) on Tuesday, October 11, 2022. The Water Act 2016 requires licensing of Water Service Providers (WSPs) for protection of consumer rights.

Water Services Regulatory Board (WASREB), Ag. Chief Executive Officer, Joseph K. Keter "ndc" (K), said public participation was a constitutional requirement for water service providers to operate.

"We are gathered here today because the constitution demands so. This is to ensure rights of citizenry are protected and that they are not exposed to water whose quality is doubtful." He stated.

He also called for drastic measures to be put in place to reduce the levels of Non-Revenue Water.

"The utilities across Kenya are losing a whopping Ksh.10.5 billion. We can't allow this trend to continue as it poses a threat to sustainability to service delivery." He said.

Nairobi County Chief Executive Committee Member in charge of Environment, Energy, Water and Sanitation, Larry Wambua, assured the Company of the new administration's support.

"The new administration led by Governor Sakaja is ready to support Nairobi Water in terms of enabling policies. Water and Sanitation forms a critical part of his manifesto. We are going to work together." He assured.

The Managing Director, Eng. Nahason Muguna, on his part did a presentation on new areas of coverage in water and sewerage services while outlining the plans and programmes put in place to enhance service delivery.

"We have gone out of our way to invest heavily in rehabilitation and expansion of the water and sewer infrastructure to cope with the ever increasing demand. We have ensured priority in reducing water loss especially through illegal connections by increasing field monitoring and apprehension of culprits found guilty of the malpractice." He stated.

## NCWSC ROLLS OUT FIRE SAFETY TRAINING PROGRAMME

The Company recently carried out in-house fire safety training and sensitization in a bid to comply with the Factories and Other Places of Work (Fire Risk Reduction) Rules, 2007) that require every employer to ensure that all workers are instructed on the safe use of firefighting appliances.

The training was also informed by recent fire incidences that have razed down Company properties and endanger the lives of the staff.

Notably, there have reported fire incidences in the recent past at the Headquarters, Cameo House, Central Region (kitchen) and Kabete Water Treatment Works' Administration Police Quarters (Unit-Huts).

The trainings covered: Fire Safety Legislation; The Chemistry of Fire; Causes of Fire; Fire Prevention and Protection Measures; Classes of Fire; Fire Fighting Equipment and their use.

Fire drills have also been conducted with the aim of providing an opportunity for all staff to assess their knowledge on the fire emergency evacuation procedures as well as their ability to evacuate the facility as guickly and safely as possible.

The drills also seek to comply with the legal requirements as provided for in Occupational Safety and Health Act, 2007 and its subsidiary legislation the Fire Risk Reduction, 2007. Planned and announced fire drills have been carried out at Ruiru Dam, Cameo House, Parklands Plaza, Sasumua Dam as well as at Kabete Water Treatment Works and Kabete Central Laboratory.

The Managing Director has since constituted as taskforce to plan and execute an announced fire drill at Kampala Road, Headquarters.
